# Purpose of the Job:

The University of Sunderland in partnership with Muckle LLP offers an exciting opportunity to a recent graduate to develop a bespoke, innovative and intelligent business analytics platform and mobile application for the legal services sector, initially addressing the debt collection marketplace for businesses, via embedded artificial intelligence and advanced data analytics.

#### **Duties of the Post:**

The main duties of the post will include:



- Exploratory research into the data held by Muckle that will lead to better understanding the technical requirement for the new platform.
- Define cloud-based infrastructures and technologies.
- Explored AI techniques including Natural Language Processing (NLP) useful in scanning and predicting what documents will be relevant to a case.
- Create a requirement specification documenting to operate with minimal human interactions.
